## ARTICLES OF INCORPORATION

To the Honorable Judges of said Court:

In compliance with the provisions of Article II of the Act of Assembly of the Commonwealth of Pennsylvania known as the "Non-profit Corporation Law" as approved May 5, 1933 and supplemented and amended from time to time, the undersigned incorporators, all of whom are citizens of the Commonwealth of Pennsylvania, having associated themselves together for the purposes herein specified, and desiring that they may be duly incorporated according to law, do hereby certify:

- l. That the name of the Corporation is "Springs Rod and Gun Club," and that said name has been registered with the Department of State within six (6) months of the date of the application for this charter.
- 2. That the location and post office address of the initial registered office of said Corporation in this Commonwealth is McClellan Street, Cambridge Springs, Crawford County, Pennsylvania.
- 3. The purpose or purposes of the Corporation are: To promote the highest standards of sportsmanship among its members; to foster and promote programs in relation to hunting and fishing and use of the rifle, shotgun, pistol and long bow, including development of rifle and pistol ranges, trap and skeet fields and archery courses; to work and cooperate in the furthering and development of various worthwhile projects and programs in relation to the conservation and stocking of all forms of wildlife in cooperation with appropriate state and federal governmental agencies, and to work for and promote the passage of constructive legislation in relation to such matters and to oppose the passage

of legislation deemed detrimental to the best interest of sportsmen generally, and to do all things necessary and incidental to the aforesaid purposes.

- 4. That the Corporation does not contemplate pecuniary gain of profit, incidental or otherwise, to its members.
  - 5. That the term of its existence shall be perpetual.

- 8. That the Corporation shall be organized on a non-stock basis.

In the event of the voluntary dissolution and winding up of the affairs of the Corporation, the assets of the Corporation, after payment of all its lawful debts and obligations, shall vest in and be distributed to the Pennsylvania Game Commission and the Pennsylvania Fish Commission, each of said Commissions to receive one-half of said net assets. Said assets to be employed by said Commissions in the carrying out of their respective activities as the directors of said Commissions shall determine. In the event that as of the time of the distribution of such assets on dissolution

or the Pennsylvania Fish Commission should not be in existence as an agency of the State Government of Pennsylvania under that name, then the portion of the assets which would have been distributable to that agency under the above provision, shall vest in and be distributed to whatever agency of the State Government, regardless of name, has assumed the duties and responsibilities of the former Commission.
